Priority Statement:

GSBA supports limits to the purchase of assault weapons, increasing the age of the purchaser for assault weapons, and instituting stricter background checks for purchases involving assault weapons. GSBA urges the General Assembly to provide funding for School Resource Officers and for mental health specialists for all public schools in Georgia.

Rationale:

Students, staff, and employee safety, security, and emergency preparedness should be a top priority of the day-to-day operations of a school district. Throughout this country mass shootings have occurred and left many school communities devastated; while the rest of us worry who will be next. Our children and staff enter buildings worried about their personal safety. We respect a citizen's right to bear arms as granted by the United States Constitution while also acknowledging that students and staff have the right to work and to be educated in a safe learning environment. Therefore, we support legislation that balances the complex intersection of rights, regulations, and responsibilities.
