The Clayton County Board of Education has tentatively adopted a millage rate which will require an increase in property taxes by 3.03 percent. All concerned citizens are invited to participate in the public hearings on the tax increase on Thursday, July 30, 2020 at 11:00 a.m. and 6:00 p.m. and on Thursday, August 6, 2020 at 6:00 p.m. Public hearings will be virtual using video-conferencing technology.

This tentative increase will result in a millage rate remaining of 20 mills. Without this tentative tax increase, the millage rate will be no more than _19.412 ___mills. The proposed tax increase for a home with a fair market value of \$100,000 is approximately \$__17.64 __ and the proposed tax increase for non-homestead property with a fair market value of \$100,000 is approximately \$__23.52 __.
