**JONESBORO** - The Clayton County Board of Education will conduct an in-person **Regular Board Meeting** on Monday, June 7, 2021. Scheduled to begin at 6:00 p.m., the meeting will be held at the Clayton County Public Schools' (CCPS) Performing Arts Center (PAC), located at 2530 Mt. Zion Parkway in Jonesboro. All comments/questions must include the name and reply email address of the submitter. Submissions without this information will not be included in those that will be read into the record during the Board meeting.
